






# APA of the Southern Right Whale


With 156.100ha and about 130km long, covers ten municipalities of Santa Catarina coast.

- First city of Santa Catarina to be listed by IPHAN










- Listed historic center
- Natural population of Luso-Brazilian origin


#### **Potentialities**

# **Deficiencies**

- Lack of a clear environmental and urbanistic planning law
  - Unused buildings in the historic center
  - Pressure for occupancy of the edges of ponds and hills
  - Disrespect to the areas of APP



# **Deficiencies**





- Lack of tourism planning
  - Lack of a marketing plan for tourism
  - Stretches of roads in poor condition and without signs
  - Poorly qualified workforce
  - Few hotel units with more comfort

# Suggestions

- Elaboration of a management plan for the APA
- Compatibility between environmental and urban planning laws
- Delimitation of preservation interest areas

- Monitoring and control of territory
- Recovery of degraded APPs
- Check the possibility of installing wind generators

- Establishing an integrated tourism plan between cities of APA
